11. DEPUTATIONS:

11.1 Heather Fullerton, Director of the Georgina Art Centre and Gallery, providing Council with information regarding the ArtXtreme event being held June 10th-11th at Crate's Marina.

Mrs. Fullerton of the Art Centre stated that she is accompanied by Brian Busby, Chairman of the Dinah Christie Celebrity Challenge Committee and ArtXtreme event and member of the Board of Directors. She explained that this Saturday's Celebrity Challenge event is a huge event which has expanded in size from previous years as demonstrated on a site plan which was displayed to Council Members. She indicated that the event includes attractions such as a custom car show, rib fest, a beer garden and a full stage, with pay-duty police officers on payroll and is arranged in association with the fire department.

Mr. Busby stated that they spoke with all of the surrounding residents who may be disturbed by noise to explain what would be occurring. They were all provided VIP tickets to the event and invited to attend.

Mrs. Fullerton stated that the ArtXtreme event is in partnership with the York Region District School Board. The ArtXtreme event will be held on Friday, June 10th and is exclusive to school groups. 580 students plus teachers and chaperones will be attending this event as a field day trip to take part in the activity areas which include an aboriginal pavilion, a soapstone carving session, making and decorating percussion instruments, static displays and interaction.

Mrs. Fullerton noted that five shuttles have been arranged to run during the two-day event to accommodate visitors.

Mr. Busby indicated that there are over 100 items donated for the silent auction and there has been an overwhelming response from the schools for the ArtXtreme event. The Committee looks forward to organizing this event annually.

Mrs. Fullerton noted that she has spoken with the Georgina Food Bank. This event is an official drop-off point for Food Bank donations and this fact has been included in the advertising posters. She also noted that the entry fee has been reduced from \$35 last year to \$10 for adults, \$5 for children 6-12 years old and free admission for children 6 years old and younger.

11.2 Karl Goinarov regarding the need for positive changes to the present rules for accessory apartments.

Mr. Goinarov stated that he obtained a copy of the proposed accessory apartment review and is in agreement with it. He explained that he is a professional landlord and owns quite a few rental units, both compliant and non-compliant. He stated that there is a desperate need for accessory apartments in Georgina. Current policies are prohibitive respecting

costs to put in an accessory apartment. He explained that it took him six months and \$10,000 to obtain a building permit for a Woodland Avenue accessory apartment which represents approximately 40% of his construction budget for the apartment. Meanwhile, it costs residents in the Towns of Newmarket and Aurora only \$150 to obtain a building permit and the process takes only two weeks.

Mr. Goinarov stated that the vacancy rate across York Region is .7%. In Georgina, only approximately two units become available for rent each month, and nothing sits empty for more than two weeks. He stated that this proposed accessory apartment process is one of the simplest ways to accomplish affordable housing and hopes that Council will approve it.

Mr. Goinarov stated that it could cost \$30,000 to bring an unfinished basement up to the building code as an accessory apartment. At the current rates, a one bedroom basement apartment could be rented for \$1,000 per month and because there is such a shortage of available units, landlords can charge whatever rate they wish.

Mr. Hiscock indicated that the Jackson's Point Conference Centre is undertaking a new initiative. The Salvation Army is engaged in disaster services internationally. Disaster Services was pioneered in the United States given the high incident rate of environmental disasters they suffer from. A program exists in the Greater Toronto Area and they have had a list of volunteers for the past ten years. Some have been through training, but the local Salvation Army is undertaking a formalization of this program.

Mr. Hiscock advised that they are hosting an information and open house session on June 18th regarding a York North Services Unit. The accredited training program deals with issues such as demand and food handling. He noted that the Salvation Army was the primary source during the 911 disaster in the United States in 2001.

Mr. Hiscock stated that they are recruiting volunteers within the community who would like to be engaged in this kind of endeavor and the open house event is the kick-off to that. He noted that they have a number of capital assets available to them including emergency vehicles, command centres, portable kitchens and eat-in centres.

Mr. Hiscock noted that as the Town grows, perhaps it will be able to contribute with emergency services, financially, or in other aspects of support. He submitted brochures for the June 18th open house event to staff at this time.

That boulevard was never sodded and is now covered with weeds. She also mentioned that the boulevard at Dovedale Drive across from the Shopper's Drug Mart store needs to be maintained.

Bob Magloughlen, Director of Engineering and Public Works, stated that he has noticed a problem with boulevard maintenance at the corner of Joe Dales Drive also. The Town cannot require the school board to maintain their boulevards and for the unsubstantial cost to maintain a boulevard, the Town could add it to their list of locations to maintain.

Mr. Magloughlen explained that the Town has a number of areas throughout its jurisdiction that require maintenance of this sort and staff is working on a standard with regard to the number of cuts required per year, depending on the amount of money the Town wishes to budget for maintaining the roadsides. He noted that the Town would not discourage residents from maintaining these boulevards themselves.
