

By-Law number 1 for the year 1888.

A By-law to appoint Auditors of Township accounts - Assessor and Collector and a Board of Health for the Township of Georgia.

Be it enacted by the Council of the Corporation of the Township of Georgia and it is hereby enacted by the authority of the same.

1<sup>st</sup> That Mr Wm Fry be and he is hereby appointed Auditor of Township accounts and the Board by virtue of his office appoints J. G. Tremayne the other Auditor for the current year.

2<sup>nd</sup> That Wm E. Tomlinson be and he is hereby appointed Assessor for the year 1888 and that he be paid for the due performance of his duties as such the sum of Seventy five Dollars per Annum.

3<sup>rd</sup> That Jno. P. Nelson be and he is hereby appointed Collector for the current year and that he be paid for the due performance of the duty of said office the sum of \$40.00 per annum.

4<sup>th</sup> That Dr. Bentley, Geo. Johnson, Henry Treloar together with the Reeve and Clerk compose the Board of Health for the Township of Georgia.

5<sup>th</sup> That all By-laws or Parts of By-laws inconsistent with the provisions of this By-law be and the same are hereby repealed.

By-law number 2 for the year 1888.

A By-law to provide for taking down and putting up fences bordering on the highways so as not to impede travel through snow drifts.

Whereas the Consolidated Municipal Act - 1883" Sec-490- Sub. Sec.-17- empowers Municipal Corporations to remove fences to stop snow drifts -

Be it therefore enacted by the Council of the Corporation of the Township of Georgina as follows:

1<sup>st</sup> That at the request of one of the Council and five rate payers the Reeve may grant his order for the removal of any snake fence that may impede the public travel through snow drifts

2<sup>nd</sup> That the sum of 10¢ per rod be allowed for taking down and replacing the same.

3<sup>rd</sup> That the occupant of the land on which the fence is situated to have the first right of removing the same on his failing to do so in twenty four hours after receiving notice the Reeve can then order any one else to carry out the order

4<sup>th</sup> That taking down all but the three bottom rails will be considered sufficient, and that all By-laws or Parts of By-laws inconsistent with this By-law are hereby repealed -

By-law number 3 for the year 1888.

A By-law to provide for the payment of gravel used on the public high-ways.

Whereas disputes have occurred in the past as to the price to be paid for gravel used by the Pathmasters on the Public Highways from private properties.

Be it Therefore enacted by the Municipal Council of the Corporation of the Township of Georgina as follows:

- 1<sup>st</sup> That a load of gravel will consist of one square yard.
- 2<sup>nd</sup> That no Pathmaster is to purchase gravel unless direct authority is granted by the Municipal Council.
- 3<sup>rd</sup> That all waggons drawing gravel must be provided with a tight bottom - with sides not less than nine inches wide - and twelve feet long.
- 4<sup>th</sup> That the price to be paid for gravel in future will be 5¢ per square yard.
- 5<sup>th</sup> That the Pathmaster must give his order on the Council in favour of the person from whom the gravel was purchased, with the following particulars - No. of loads - No. of square yards. No. of loads gravelled. Location of road gravelled.

A By Law to provide and appoint Polling Places and Deputy Returning Officers for the respective Polling Sub. Divs in the Township of Georgina for the Municipal Election of the year 1889.

Be it enacted by the Council of the Municipality of Georgina and it is hereby enacted by the authority of the same.

1. That the Polling Place for Sub. Div. No 1. be at Sheppard's Hall Sutton and that Henry Ireland be and is hereby appointed Deputy Returning Officer.
2. That the Polling Place for Sub. Div. No 2 be at The Pefferlaw Hall and that George Johnson be and is hereby appointed Deputy Returning Officer.
3. That the Polling Place for Sub. Div. No 3 be at the School House near Uctora and that Christopher Raymond be and is hereby appointed Deputy Returning Officer.
4. That the Polling Place for Sub. Div. No 4. be at Yates Shop Egypt and that John Yates be and is hereby appointed Deputy Returning Officer.
5. That in the event of an Election being held the said Deputy Returning Officers shall be paid for their services as much the sum of Four Dollars each and their respective Poll Clerks the sum of Two Dollars each. Constables when employed the sum of one Dollar and

Fifty cents each and that the Board grant orders for payment on the Treasurer on demands after the same has become due.

6. That all By laws or Parts of By laws inconsistent with the provisions of this By law be and the same are hereby repealed.

By law number 12 for the year 1888.
