Be By-Law to appoint Auditors of Township accounts, Collector, Assessor, also a Board of Health for the Township of Georgina for the Year 1895.

Be it enacted by the Municipal Council of the Township of Georgina.

- 3rd That the Polling place for sub-division No 2, be at the Pepperlaw Hall, and that George Johnson be and is hereby appointed Deputy returning officer,
- 4th That the Polling place for sub-division No 3 be at the school house near Adora, and that Christopher Raymond be and is hereby appointed Deputy Returning officer,
- 5th That the Polling place for sub-division No 4 be at Yater's house Egypt, and that John Yater be and is hereby appointed Deputy Returning officer,
