Be it enacted by the Municipal Council of the Township of Georgina,

1st That Henry Corner and John M. Davies be and are hereby appointed auditors of Township accounts for 1896, and that they be paid the sum of \$4- each, for the due performance of the duties of said office,

2nd That W. E. Tomlinson be and is hereby appointed Assessor for 1896, and that he be paid for the due performance of his duties as such the sum of \$50-

3rd That Joseph S. Kay be and is hereby appointed Collector for 1896, and that he be paid for the due performance of his duties as such the sum of \$42-

4th That John J. Graham, Charles Galbraith and John Johnston, together with the Reeve and Clerk do compose the Board of Health for the Township of Georgina, the first named is appointed for three years, the second for two years and the third for the current year only,

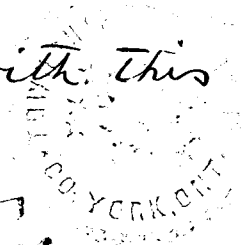
5th That all By-Laws inconsistent with this By-Law are hereby repealed.

By-Law No 7 for 1896.

A By-Law to provide a place and time for holding nomination, also appointing polling places and Deputy Returning Officers, for the Municipal Election Township of Georgina for the year 1897, and also the election under the County Councils Act,

Be it enacted by the Municipal Council Township of Georgina,

- 1st That the nomination for the year 1897, be held at the Pfefferlaw Hall in the said Township of Georgina, and that said nomination be held at the hour of one o'clock P.M.
- 2nd That the Polling place for sub-division No 1 be at School House Virginia, and that George Evans be and is hereby appointed Deputy Returning Officer,
- 3rd That the Polling place for sub-division No 2 be at Pfefferlaw Hall, and that Henry Garner be and is hereby appointed Deputy Returning Officer,
- 4th That the Polling place for sub-division No 3 be at School House Uctora, and that Christopher Rynard be and is hereby appointed Deputy Returning Officer,
- 5th That the Polling place for sub-division No 4 be at Yates House, and that John Yates be and is hereby appointed Deputy Returning Officer,

6th That in the event of a municipal election being held, that the said Deputy Returning Officers shall be paid for their services as such the sum of \$4- each, and their respective poll clerks the sum of \$2- each, and constables when employed the sum of \$1- each,

7th That all By-Laws inconsistent with the provisions of this By-Law be and the same are hereby repealed.—
