By-Law No 3. for 1897

A By-Law to appoint appraisers to value
sheep killed or injured by dogs

Whereas Chapter 214 B. S. D. requires Township
Councils to compensate the owners of sheep for
the damage done by dogs, where the owner of
such dogs cannot be found,

And whereas it is incumbent on municip-
al Councils to thoroughly investigate all appli-
cations for damages under the above act, and
fully satisfy themselves of the loss actually sus-
tained by the parties applying,

And whereas it is deemed necessary for
the purpose of better arriving at the value of
the sheep so killed or injured, to appoint ap-
praisers for that purpose,

Therefore the Council of the Township of
Georgina enacts that the following named per-
sons (and their successors in office) be and
they are hereby appointed appraisers for the
purpose of valuing all sheep killed or injured
by dogs, whose owners intend applying to the
Council for compensation under the provisions
of the aforesaid act

It shall be the duty of the aforesaid appraisers, on being notified, to proceed to the place where sheep have been killed or injured within his division, and make and give to the owner thereof a valuation in writing and signed by him, which valuation shall be taken to the Council and used as evidence as to the amount of injury done,

The appraisers shall receive as pay for their services the sum of one dollar for each occasion on which they are called to make a valuation,

Be it further enacted that no claim for damage not valued by one of the aforesaid appraisers or their successors in office, shall be entertained by the Council,

By-Law No 4 for 1897,

A By-Law to detach $3\frac{1}{2}$ lot 4 in the 5th concession, from Union S. S. No. 1, and attach same to S. S. No 3,

Whereas by section 35 of the Public Schools Act 1896, power is given to municipal councils to pass By-laws to unite portions of an existing section, with another section,

And whereas the necessary notices according to Statute have been given,

Be it therefore enacted by the Municipal Council of the Township of Georgina, that the $3\frac{1}{2}$ of lot 4 in the 5th Con. Township of Georgina be detached from S. S. No. 1, and that the same be attached to S. S. No 3,

That this By-law shall take effect and come into force on the 31st day of December 1897, and that all By-laws or parts thereof inconsistent herewith be and the same are hereby repealed,

By-law No 5, for 1897.

A By-law to divide School Section No 5, into two separate Sections,

Whereas by Section 38 of the Public Schools Act 1896, power is given to Municipal Councils to pass By-laws to divide existing sections into two or more sections,

And whereas the necessary notices according to Statute have been given,

Be it therefore enacted by the Municipal Council of the Township of Georgina, that a new School Section be set apart out of the present School Section No 5, to be composed of lots twelve to twenty inclusive in the 1st & 2nd Concessions, and lots thirteen to twenty inclusive in the 3rd Concession of the said Township of Georgina, said new section to be called and known as School Section No 8,

Be it further enacted that in case the Trustees of said sections numbers five & eight fail to agree or come to an amicable settlement of all rights and claims consequent upon such division, that Donald McDonald and W^m E. Tomlinson be and are hereby appointed Arbitrators, under Section 40 of the Public Schools Act; to act in conjunction with the Inspector to settle all claims in dispute, and that this By-law take effect and come into force on the 31st day of December 1897, and that all By-laws inconsistent herewith, be and the same are hereby repealed. —

By-Law No 10 for 1897

A By-Law to provide a place and hour for holding nomination, also appointing polling places and Deputy Returning Officers, for the Municipal Election Township of Georgina for the year 1898,

Be it enacted by the Municipal Council Township of Georgina,

- 1st That the nomination for the year 1898 be held at the Pefferlaw Hall in the said Township, and that said nomination be held at the hour of One o'clock,
- 2nd That the Polling place for sub-division No 1, be at Old Meeting house Virginia, and that George Evans be and is hereby appointed Deputy Returning Officer,
- 3rd That the Polling place for sub-division No 2, be at Pefferlaw Hall, and that Henry Corner be and is hereby appointed Deputy Returning Officer,
- 4th That the Polling place for sub-division No 3, be at School House near Udora, and that Christopher Rymard be and is hereby appointed Deputy Returning Officer,
- 5th That the Polling place for sub-division No 4, be at Yates House Egypt, and that John Yates be and is hereby appointed Deputy Returning Officer,
- 6th That in the event of an election being held that the said Deputy Returning Officers shall be paid for their services as such the sum of \$4- each, and their respective poll clerks the sum of \$2- each, and constables when employed the sum of \$1.⁰⁰ each, and that all By-laws inconsistent herewith be and the same are hereby repealed.
