A By-Law to appoint Auditors, Assessor, Collector, Member of the Board of Health, also Medical Health Officer for the Township of Georgina for the year 1898,

Be it enacted by the Municipal Council of the Township of Georgina

- 1<sup>st</sup> That Henry Corner and John M. Davies be and are hereby appointed Auditors of Township accounts, and that they be paid the sum of \$4.00 each for the due performance of the duties of said office.
- 2<sup>nd</sup> That W. E. Tomlinson be and is hereby appointed Assessor, and that he be paid for the due performance of his duties as such the sum of \$60.00,
- 3<sup>rd</sup> That Joseph S. Kay be and is hereby appointed Collector, and that he be paid for the due performance of his duties as such the sum of \$42.00,
- 4<sup>th</sup> That Charles Galbraith be and is hereby appointed Member of the Board of Health for the next ensuing term,
- 5<sup>th</sup> That C. J. Hobbs be and is hereby appointed Medical Health Officer,
- 6<sup>th</sup> That all By-laws inconsistent with the provisions of this By-law, be and the same are hereby repealed.

## By-Law No 7 for 1898

A By-law to provide a place and appoint an hour for holding nomination, also appoint Polling places and Deputy Returning Officers for the municipal election Township of Georgina for the year 1899.

Be it enacted by the Municipal Council  
Township of Georgina

- 1<sup>st</sup> That the nomination for the year 1899 be held at the Peppelaw Hall at the hour of one O'clock,
- 2<sup>nd</sup> That the polling place for sub division no 1 be at the old meeting house Virginia, and that George Evans be and is hereby appointed Deputy Returning Officer,
- 3<sup>rd</sup> That the polling place for sub division no 2 be at the Hall Peppelaw, and that Henry Corner be and is hereby appointed Deputy Returning Officer,
- 4<sup>th</sup> That the polling place for sub division no 3 be at the School House near Udora and that Christopher Rynard be and is hereby appointed Deputy Returning Officer,
- 5<sup>th</sup> That the polling place for sub division no 4 be at Gates House Egypt; and that John Gates be and is hereby appointed Deputy Returning Officer,
- 6<sup>th</sup> That in the event of an election being held that the said Deputy Returning Officers shall be paid for <sup>their</sup> services the sum of \$4.00 each, and their respective Poll Clerks the sum of \$2.00, each, and Constables when employed the sum of \$1.00 each, and that all By-laws inconsistent herewith be and the same are hereby repealed,

## By-Law No 8 for 1898
