A By-law to appoint Auditors, Assessor, Collector member of the Board of Health and Medical Health Officer for the Township of Georgina for the year 1899,

The Municipal Council of the Township of Georgina in the County of York enacts as follows,

- 1<sup>st</sup> That Henry Corner and John M. Davies be and are hereby appointed Auditors of Township accounts, and that they be paid the sum of \$4.<sup>00</sup> each for the due performance of the duties of said Officer,
- 2<sup>nd</sup> That W. E. Tomlinson be and is hereby appointed Assessor, and that he be paid for the due performance of his duties as such the sum of \$50.<sup>00</sup>,
- 3<sup>rd</sup> That Joseph S. Kay be and is hereby appointed Collector, and that he be paid for the due performance of his duties as such the sum of \$42.<sup>00</sup>,
- 4<sup>th</sup> That John J. Graham be and is hereby appointed member of the Board of Health for the next ensuing term,
- 5<sup>th</sup> That Dr. Noble be and is hereby appointed Medical Health Officer for this Municipality,
- 6<sup>th</sup> That all By-laws inconsistent with the provisions of this By-law, be and the same are hereby repealed, —

## By-Law No 5 for 1899

A By-law to authorize the Reeve and Treasurer of the Corporation of the Township of Georgina to procure gravel for keeping the roads and Highways in repair within the Municipality;

Whereas it is necessary to procure gravel for the purpose of keeping in repair the roads or highways of the Township of Georgina,

And whereas the right to remove gravel from an acre off the east-half of lot number six in the sixth Concession of the Township of Georgina more particularly described as follows:

Commencing at a point on the easterly limit of said east half of lot number six in the sixth Concession of said Township of Georgina at the distance of sixty-seven rods and eight feet southerly from the north easterly angle of said east half of lot number six, thence southerly along the easterly limit of said east half of lot number six twelve rods, thence westerly parallel with the northerly limit of said lot thirteen and one third rods, thence northerly parallel with the easterly limit of said lot twelve rods, thence easterly parallel with the northerly limit of said lot thirteen and one third rods to the place of beginning;

Can be obtained for the period of twenty years from the 17<sup>th</sup> day of June A.D. 1899 from the owner or owners thereof for the sum of two hundred Dollars, providing the gravel is not excavated to a greater depth than the level of the land on said lot adjoining to the north, and it is expedient to authorize the Reeve

and Treasurer to enter into a covenant or agreement to purchase said acre at a sum not to exceed the sum above mentioned,

Therefore the Municipal Council of the Township of Georgina enacts as follows

- 1<sup>st</sup> That the Reeve and Treasurer be and the same are hereby authorized to purchase said property herein before described from the owner or owners thereof for a sum not to exceed Two Hundred Dollars,
- 2<sup>nd</sup> That an agreement to purchase said property hereinbefore mentioned be entered into by and between the owner or owners thereof and the Reeve and Treasurer on behalf of and under the Seal of the Corporation for the privilege of removing gravel for the purpose aforesaid and for the period above mentioned, and upon such other terms as may be agreed upon between the owner or owners of said property and the Reeve and Treasurer of said Municipality.

A By-law to make provisions for the payment of certain Township officers for the year 1899.

Be it enacted by the Municipal Council of the Township of Georgina

Commissioners each per day the sum of 2.00

Selectors of Jurors each per day the sum of 2.00

Members of Health each per day the sum of 2.00

And that the Reeve grant his orders on the Treasurer in accordance herewith, and that all By-laws inconsistent with the provisions of this By-law be and the same are hereby repealed.

By-Law No 7 for 1899

A By-law to appoint a place and time for holding nomination also polling places and Deputy Returning Officers for the Municipal Election Township of Georgina for the year 1900,

Be it enacted by the Council of the Township of Georgina

- 1<sup>st</sup> That the nomination for the year 1900 be held at the Pefferlaw Hall at the hour of one O'clock P.M.
- 2<sup>nd</sup> That the polling place for subdivision No 1 be at the old meeting house Virginia, and that George Evans be and is hereby appointed Deputy Returning Officer,
- 3<sup>rd</sup> That the polling place for subdivision No 2 be at the Hall Pefferlaw, and that Henry Corner be and is hereby appointed Deputy Returning Officer,
- 4<sup>th</sup> That the polling place for subdivision No 3 be at the School House Udora, and that Christopher Ryward be and is hereby appointed Deputy Returning Officer,
- 5<sup>th</sup> That the polling place for subdivision No 4 be at Stattons Hall Egypt, and that Robert Mc Blellan be and is hereby appointed Deputy Returning Officer,
- 6<sup>th</sup> That in the event of an election being held, that the said Deputy Returning Officers shall be paid for their services the sum of \$4.<sup>00</sup> each, and their respective Poll clerks the sum of \$2.<sup>00</sup> each, and constables when employed the sum of \$1.<sup>00</sup> each, and that all By-laws inconsistent herewith be and the same are hereby repealed.
