

## By-Law No 81

A By-Law to amend By-Law No 10.

Whereas the Council of the Township of Georgina have passed a By-Law imposing a tax on Dogs and Bitches.

And whereas it is deemed advisable to amend said By-Law.

Be it therefore enacted by the Council of the Township of Georgina in the County of York -that said By-Law No 10 passed on the 2<sup>nd</sup> Day of December 1893, be amended by adding the following sub section thereto.

That in cases where parties have been assessed for any Dog or Bitch, that no such Dog or Bitch shall be struck off the assessment Roll for the year in which they are assessed, unless the party assessed therefor apply at the Court of Revision for the said year, and make an affidavit that said Dog or Bitch have been destroyed or done away with as the case may be, and if they have no other Dog, <sup>or</sup> Bitch in their possession then the Court can strike said Dog or Bitch of the Roll, but after the date of the passing of this By-Law No Dog Tax will be refunded to any person who is assessed for a Dog or Bitch at the date that the Assessment Roll is confirmed and adopted by the Court of Revision.,,
