## By-Law No 106

A By-Law to provide for the sale of a portion of the 8" Con Line opposite Lot 24, also to establish a Road in lieu therefore leading from the line between E. G. Corner and Thomas Churnside, west and northwesterly to the waters edge of Lake Simcoe.

Be it enacted by the Municipal Council of the Township of Georgina in the County of York,

1st

That all that portion of the 8" Con Line opposite Lot 24 from the line between E. G. Corner and Thomas Churnside westward to the Lake be sold and conveyed to E. G. Corner save and except that portion of same used and contained in a Roadway which is hereby established leading from the line between E. G. Corner and Thomas Churnside westward and northwesterly to the waters edge of Lake Simcoe, as shown in a plan marked A which is attached to and hereby becomes part of this By-Law on condition that the said E. G. Corner deed over unto the Corporation of the Township of Georgina all the land required for said roadway over and above that portion which ~~which~~ is part of the original road allowance and also that he level up and make fit for travel that part of said roadway from where it turns northwesterly to the waters edge and that he bear all the expense in connection with said transfers and the Registration of all deeds and that the Reeve be and is hereby authorized to execute a Deed on behalf of this Corporation for said piece of roadway to the said E. G. Corner when he is satisfied that the above mentioned conditions have been or will be faithfully carried out.



A By-Law to appoint a Township Treasurer for the Township of Georgina.

The Municipal Council of the Township of Georgina in the County of York enacts as follows.

1<sup>st</sup>

That W. C. Evans be and is hereby appointed Treasurer of the Township of Georgina, whose duty shall be to deposit with the Council a Bond to the extent of Fifteen Thousand Dollars, duly executed by himself and two good and efficient sureties to be approved of by the Council, and to receive all monies belonging to the Municipality from whatsoever
