By-law No 143

A. By-law to authorize and empower the Reeve and Treasurer to borrow funds to meet current expenditure until the taxes are collected.

The Municipal Council of the Township of Georgina in the County of York enacts as follows:-

That the Reeve and Treasurer of this Township be and are hereby empowered to borrow on the credit of the Corporation such sums as may be required to meet current expenditure, until the taxes are collected, but not to exceed (\$000) two Thousand Dollars.

By-law No 144

A By-law to divide School-Section No 4 and thereby form a new section:

Whereas by section 15 of The Public Schools Act, power is given to Municipal Councils to divide existing School-Sections into two or more sections

and whereas all parties affected thereby have been notified in a manner deemed expedient by the Council

Be it therefore enacted by the Council of the Township of Georgia in the County of York

12th That a New School-Section be set apart out of the present School-Section No 4, to be composed of lots number 17-18 & 19 inclusive in the fourth and fifth concessions of the Township of Georgia said new section to be called and known as School-Section No 9.

2nd Be it further enacted that in case the Trustees of said Section Nos 4 & 9 fail to agree or come to an amicable settlement of all rights & claims consequent upon ~~such~~ such division that Donald Ego and Phillip Shier be and are hereby appointed arbitrators under section 18. of "The Public Schools Act" to act in conjunction with the Public School Inspector to settle all claims in dispute and that all By-laws or parts thereof inconsistent herewith be and the same are hereby repealed

By-law No 145

A By-law to authorize the issue and sale of Debentures for the sum of six thousand Five Hundred Dollars, for the purchase of a School-site and the erection and equipment of a School-house in School-Section No 9 of the Township of Georgia:

Whereas the Board of Trustees of said School-Section have applied to the Council to raise the sum of six thousand Five Hundred Dollars by a loan upon the Debentures of the said Corporation extending over a period of thirty years, and repayable by equal annual instalments of principal and interest, and

Whereas for the payment of said Debt and interest the respective sums hereinafter set forth will be required to be raised annually by a special Rate over and above all other rates in each of the years during the currency of the said Debentures upon the rateable property of the Public School supporters of the said School-Section - and

Whereas the proposed loan has been submitted to and sanctioned by a special meeting of the Ratepayers of said School-Section and -

Whereas the amount of the whole rateable property of the said School-Section is, according to the last revised assessment Roll, one thousand and two thousand seven hundred Dollars - and -

Whereas the said School-Section has no existing Debenture Debt - and -

Whereas the amount of the whole rateable property of the Township of Georgia is, according to the last revised assessment Roll, nine hundred and thirty-six thousand three hundred Dollars, - and -

Whereas the Township of Georgia has an existing Debenture Debt of seven thousand Dollars and fifty-one cents - (\$4070.98 School-Section No 3 Debentures and \$5959.53 Bridge Debentures).

(By-law No 145 cont)

Therefore the Municipal Council of the Township of Georgina in the County of York enacts as follows.

1st That the sum of six thousand five hundred dollars (\$6,500.00) so required by the Board of Trustees of School Section No 9 be raised by the issue of Debentures as hereinafter mentioned, and that the proceeds of said Debentures be paid over to the Treasurer of the said Public School Board for the purpose herein before mentioned

2nd That for the purpose of effecting such a loan as aforesaid, it shall be lawful for the Reeve of the Township of Georgina to issue or caused to be issued Debentures for sums not less than one hundred dollars and not exceeding in the total amount Six thousand Five hundred, the same to be sealed with the Corporate Seal, and to be signed by the Reeve and countersigned by the Treasurer of the said Municipality which Debentures shall be marked and known as Public School Debentures.

3rd That the said Debt & Debenture shall bear interest at the rate of five per centum (5%) per annum, and shall be payable at the Standard Bank Pefferlaw, in equal annual instalments covering both Principal and Interest according to the following schedule, and on the days and year therein set out. —

That for the purpose of providing a fund for the payment of said principal and interest due from year to year as such Debentures may mature, there shall be raised and levied in each and every year during the said period of thirty years on all the rateable property of the Public School Supporters of the said School Section No 9, by a special Debenture Rate over and above all other rates a sufficient sum (\$ 422.83.) as respectively hereinbefore mentioned and set out in said schedule for the payment of each instalment of principal and interest and the said sum is to be raised and levied in the years mentioned and set out in said schedule.

2nd That the Polling Booth for Polling sub-division No 1 be at Methodist Hall Virginia and that Ed. Cronsberry be the Deputy R. Officer and Willard Arnold Poll-clerk.

3rd That the Polling Booth for Polling sub-division No 2 be at the Hall Pefferlaw and that Jnos Pomer be the Deputy R. Officer and Jnos Shearer Poll-clerk.
