By-law No 151

A By-law to authorize the issue, and sale of Debentures, for the sum of Three Thousand Dollars (\$3,000.00), for the purchase of a school-site and the erection and equipment of a school house in school section No 4 of the Township of Georgia:

Whereas the Board of Trustees of said school section No 4, have applied to the Council to raise the sum of Three Thousand Dollars (\$3,000.00), by a loan upon the Debentures of the said Corporation of the Township of Georgia extending over a period of Twenty years, and repayable by equal annual instalments of principal and interest, and-

Whereas for the payment of said debt and interest the respective sums hereinafter set forth will be required to be raised annually by a special Rate over and above all other Rates, in each of the years, during the currency of the said Debentures, upon the Rateable Property of the Public School Supporters of the said School-section No 4 and-

Whereas the proposed loan has been submitted to, and sanctioned by a special Meeting of the Ratepayers of the said Public School section, and-

Whereas the amount of the whole Rateable Property of the said Public School-section No 4 is, according to the last revised Assessment Roll Seventy-seven Thousand Dollars (\$77,000.00) and

Whereas the said Public School-section No 4 has no existing Debenture debt, and-

Whereas the amount of the whole Rateable Property of the Township of Georgia is according to the last revised Assessment Roll Nine Hundred and Thirty-six Thousand Three Hundred Dollars (\$936,300.00) and

Whereas the Township of Georgia has an existing Debenture debt of

Journal Dec 1st 1916

Thirteen Thousand and Thirty six Dollars and Twenty cents. (\$ 13 036 20) as follows. Three Thousand Nine Hundred and Thirteen Dollars and Forty-six cents (\$ 3,913.46) Debenture Debt School-section No 2, Two Thousand six Hundred and Twenty-two Dollars and Seventy-Four cents (\$ 2,622.74) Bridge Debenture, and Six Thousand Five Hundred Dollars (\$ 6,500.00) Debenture Debt School-section No 9.

Therefore the municipal Council of the Township of Georgia in the County of York, - in the Province of Ontario enacts as follows: -

1st That the sum of Three Thousand Dollars (\$ 3,000.00), so required by the Board of Public School Trustees of School-section No 4, Be raised by the issue and sale of Debentures as hereinafter mentioned, and that the proceeds of the sale, of said Debentures be paid over to the Treasurer of the said Public School Board for the purpose hereinafore mentioned

2nd That for the purpose of effecting such a loan as aforesaid it shall be lawful for the Reeve of the Township of Georgia to issue or cause to be issued Debentures for sums of not less than one hundred each, and not exceeding in the total amount Three Thousand Dollars (\$ 3,000.00), the same to be sealed with the Corporate Seal, and to be signed by the Reeve and countersigned by the Treasurer of the said Township of Georgia, which said Debentures shall be marked and known as Public School Debentures.

3rd That the said Debt and Debentures shall bear Interest at the Rate of Five per centum (5%) per annum, and said Debentures shall be payable at the Standard Bank Pefferlaw in equal annual Instalments covering both principal and Interest, according to the following Schedule and on the days and Dates hereinafter set out: -
