A By. Law to appoint a Medical Health Officer also Sanitary Inspector for the Township of Georgina

Whereas the Medical Health Act provides that every Municipal Council shall appoint a Medical Health Officer also a Sanitary Inspector or Inspectors,

Therefore the Municipal Council of the Township of Georgina in the County of York enact as follows,

- 1st That Dr R. J. Paul be and is hereby appointed Medical Health Officer of the Township of Georgina, and that he be paid the sum of one Hundred Dollars per annum for the due performance of his duties as such Medical Health Officer.
- 2nd That George Arnold, John Griffin, Jos W. Westgath and William Browder be and are hereby appointed Sanitary Inspectors in their respective polling sub divisions and that they be paid at the rate of Four Dollars per day for the time actually employed in the discharge of their duties.

A By-Law to appoint Auditors, Assessor, collector of Taxes, School attendance Officer, members Board of Health and Sheep Valuator for the Township of Georgina for the year 1920.

By-Law No 190

A By-Law to provide for expenditure on Roads in the Township of Georgina during the year 1920,

Whereas the regulations of the Department of Public Highways of Ontario require that the expenditure on Township Roads under the Ontario Highways Act, and amendments thereto, shall be provided for annually by Township By-Law,

Therefore the Council of the Municipal Corporation of the Township of Georgina Enacts as follows,

- 1st. The sum of \$1700- is hereby appropriated from monies raised by Taxation for expenditure upon construction on the roads in the said Township during the year 1920,
- 2nd That the sum of \$2800. is hereby appropriated from monies raised by Taxation for expenditure upon maintenance and repair on the roads in the said Township during the year 1920,
- 3rd The said monie shall be expended under the direction of the duly appointed Township Road Commissioners,
- 4th All work on which the said monies shall be expended shall be performed in accordance with the last revised regulations respecting Township roads issued by the Department of Public Highways of Ontario,
- 5th The Clerk shall transmit two certified copies of this By-Law to the Deputy Minister Department of Public Highways of Ontario, within thirty days after the passing thereof.

A By. Law to appoint an hour and place for holding nomination also polling booths and Deputy Returning Officers and Poll Clerks for the Municipal Election of January 3rd 1921

The Council of the Township of Georgina in the County of York enacts as follows.

- 1st That the Nomination Meeting for the year 1921 be held at the Hall Pefferlaw on Monday Dec 27th between the hours of one and two o'clock in the afternoon,
- 2nd That the Polling booth for polling division no 1 be at the Methodist Hall Virginia and that Willard Arnold be Deputy Returning Officer and Frank Lyons Poll Clerk
- 3rd That the Polling booth for polling division no 2 be at the Hall Pefferlaw and that Thos Shraun be Deputy Returning Officer and John Garner Poll Clerk
- 4th That the Polling booth for polling division no 3 be at the School House Adona and that Joseph Westgarth be Deputy Returning Officer and Wm Harvey Poll Clerk
- 5th That the Polling booth for polling division no 4 be at Station Hall Egypt and that John M. Riddell be Deputy Returning Officer and and Wilbur Riddell Poll Clerk
- 6th That in the event of an Election being held that the said Deputy Returning Officers shall be paid the sum of \$5.00 each and the said Poll Clerks \$3.00 each and Constables when employed \$2.00 each and booths \$2.00.
