By. Law No 204

A By. Law to provide for expenditure on roads in the Township of Georgina during the year 1922.

Whereas the regulations of the Department of Public Highways of Ontario require that the expenditure on township roads under the Ontario Highways Act and amendments thereto shall be provided for annually by Township By. Law.

Therefore the Council of the Municipal Corporation of the Township of Georgina enacts as follows

- 1st The sum of \$1500- is hereby appropriated from monies raised by taxation for expenditure upon construction on the roads in the said township during the year 1922,
- 2nd The sum of \$3000- is hereby appropriated from monies raised by taxation for expenditure upon maintenance and repair on the roads in the said township during the year 1922,
- 3rd The said monies shall be expended under the direction of the duly appointed township road Commissioner,
- 4th All work on which the said monies shall be expended shall be performed in accordance with the last revised regulations respecting township roads issued by the Department of Public Highways of Ontario,
- 5th The Clerk shall transmit two certified copies of this By. Law to the Deputy Minister Department of Public Highways of Ontario, within thirty days after the passing thereof.

The Municipal Council of the Township of Georgina in the County of York meets as follows.

- 1st That the Nomination meeting for the year 1923 be held at the Pefferlaw Hall on Friday Dec 22nd 1922 between the hours of one and two o'clock in the afternoon.
- 2nd That the polling booth for polling division No 1 be at the Methodist Hall Virginia and that Willard Arnold be Deputy Returning Officer and Clarence Rutter Poll clerk.
- 3rd That the polling booth for polling division No 2 be at the Hall Pefferlaw and that Thomas Shraer be Deputy Returning Officer and John Corner Poll clerk.
- 4th That the polling booth for polling division No 3 be at the School House Udena and that Joe W. Westgath be Deputy Returning Officer and William Harvey Poll clerk.
- 5th That the polling booth for polling division No 4 be at the Methodist Hall Egypt and that Wil. Fred Riddell be Deputy Returning Officer and James Sinclair Poll clerk.
- 6th That in the event of an Election being held that the said Deputy Returning Officers shall be paid \$4.00 each, and Poll clerks \$2.50 each and Constables when employed \$1.00 each, and that \$2.00 be allowed for each polling booth.
