

## First Meeting 1933

Pursuant to statute the following members of Georgina Council met at Pefferlaw on Monday January 9<sup>th</sup>. 1933 at 11. a.m.

Reeve, R. H. Corner, Councillors, J C Taylor, Ivan Tomlinson, A. J. Weatherall, and J. D. Sibbald.

After subscribing to the necessary declaration of office they took their seats at the Council Board for the year 1933.

Communications were read, and dealt with.

A petition from School Section no 6 re Union School Section it was moved by Councillor Taylor seconded by Councillor Sibbald that this Council accept the petition as presented from the ratepayers of school section no 6 of the Township of Georgina asking for the formation of a Union Section of part of the Township of Scott and said section, on conditions that same be accepted by the Township of Scott, and that J. H. Humphrey be and hereby appointed Arbitrator for the Township of Georgina. Carried.

Moved by Councillor Sibbald seconded by Councillor Taylor that the Reeve and Councillor Weatherall be appointed a committee to interview John Moore and are authorized to make him an offer for the Wesley Godfrey Corner and report at the next regular meeting. Carried.

Moved by Councillor Sibbald seconded by Councillor Weatherall that W. H. Taylor and Richard Cranberry be and are hereby appointed Wood Inspectors for the Township of Georgina for the year 1933. Carried.

Moved by Councillor Sibbald seconded by Councillor Tomlinson that the Community Hall Board be authorized to purchase wood to heat the Hall for the Agricultural Courses to be held from Jan. 9<sup>th</sup> to Feb. 3<sup>rd</sup> both days inclusive at the expense of the Township of Georgina, not to exceed \$12.50. Carried.

Moved by Councillor Weatherall seconded by Councillor Tomlinson that the Reeve and Clerk be authorized to sign and submit to the Minister of Public Highways of the Province of Ontario the petition of the Corporation of the Township of Georgina showing that during period Jan. 1<sup>st</sup> 1932 to Dec. 31<sup>st</sup> 1932 there has been expended upon the Township Roads \$4821.41 and requesting the statutory grant on that amount as provided by the Ontario Highways Act and amendments thereto. Carried.

Moved by Councillor Libbald seconded by Councillor Weatherall that the Collector's time for returning the Roll be extended until the February meeting. Carried.

Moved by Councillor Tomlinson seconded by Councillor Taylor that the opening of Snow Roads during the winter months be left entirely to the Councillor in his Division and save the expenses of the Road supervisor. This work to be done at 15 cents per hour for man and 30 cents per hour for man and team, and that the Council will not pay for work done unless said work is authorized by a member or members of the Council.
