By Law No 2

A By Law to regulate the writing and advertising of the receipts and expenditure of this Township for the year 1851

Therefore be it enacted by the Municipality of the Township of North Gwillimbury and it is hereby enacted that the Clerk be authorized to write Five Copies of the Receipts and expenditure of this Township for the year 1851 as made out by the Auditor, and that he post them or cause them to be posted as follows viz,

One at Nelson Croes Tavern East Gwillimbury
One at Hiram Moores Tavern North Gwillimbury
One at William Bouchers store North Gwillimbury
One at Charles Jones Tavern North Gwillimbury
and one at James Hartneys Tavern Sutton.

And be it further enacted that he shall have them all wrote and posted up on or before the 19th day of February 1851 and that he shall receive the sum of Five Shillings for each and every one of them so wrote and posted up and that the Township Meere be authorized to give an order on the Treasurer for the payment of the same as soon as the work is completed.

By Law No 3

A By Law to repeal By Law No 5 of the Late Municipal Council of this Township for the year 1851

Therefore be it enacted by the Municipality of this Township and it is hereby enacted that from and after the passing of this By Law By Law No. 5 of the Late Municipality of this Township for the year 1851, is hereby repealed.

By Law of the Corporation

For the better regulation of Taverns.

It hereby for the better regulation of Taverns the Inspector of Taverns shall and they are hereby required to visit the houses of applicants for Licence and enter into and examine such house and accommodations and in no case to grant to such applicants their certificates till after such inspection as herein after required.

First, that every such house shall have at least three bed rooms for the accommodation of Travellers independent of the necessary apartments for the use of the family,

Secondly, such house so to be Licensed shall have within a convenient distance of such house a comfortable stable attached to said house suitable for the accommodation of at least six Horses beside these usually kept therein

And be it enacted, that each and every Inspector granting certificates to any person or persons without first examining such house and accommodations as herein required, shall forfeit and pay the sum of Five Pounds or more to be recovered as all other fines as by By-Laws of the Municipal Council direct, and be it further enacted that in addition to any sum as required by the Imperial act Charles Jones pay the sum of Two Pounds and Sixpence above the sum of Two Pounds here shillings

And be it further enacted, that every Tavern Keeper shall keep an orderly house at all times and not allow any fighting or other disorderly Conduct nor suffer or allow any abusive language to any person or persons visiting or entering peaceably or quietly his house, and to see such person or persons leave without let or hindrance,

And be it further enacted that every person keeping such Tavern shall not allow the assembling of any number of persons on the Sabbath day but shall keep the house closed

Closed from Ten o'clock A. M. to Twelve o'clock at noon and from Two to Four P. M.

Provided always the same shall not apply to Travellers, his house shall be open for the reception of such person or persons, and such Tavern Keepers are hereby required to give such accommodation as may be required, and in default of observing or refusing to conform to the above regulations he shall forfeit and pay the sum of not less than One Pound or more than Five Pounds Provided always that no such fine shall be inflicted unless on the oath of such Complainant and confirmed by one or more creditable witnesses, and the same shall be collected as all other fines, as by By Laws imposed and in the same way and manner.

And be it enacted That the Inspectors are hereby required to visit and inspect such Taverns, between the Fifteenth and Twenty fifth day of February

By Law &c &c

To Provide for the Maintenance and support of George Williams an indigent blind Man

Be it enacted and the same is hereby enacted that the sum of Three Shillings and Nine Pence be allowed per Week for his Maintenance and support washing and mending included and that Sephus Good and Henry Bennett be appointed as Trustees to carry into effect the intent and meaning of this By Law and it shall be the duty of such Trustees to see him placed with such person or institution as they deem advisable for his necessary support as herein required,

Provided always that nothing herein contained shall be construed to extend beyond the last day of December of the present year and that the same be paid out of the Township funds and the Treasurer is hereby authorized to pay the same as required on order signed by the Township Treas.

By Law No. 8

A By Law to restrain certain Cattle, Horses and other animals from running at large for the present year.

Therefore be it enacted by the Municipality of the Township of North Guilford and it is hereby enacted that from and after the passing of this By Law, all Horses, Colts, Bulls, Boars, Rams, Stags and also all Hogs, and Pigs of any description shall not be free commoners nor shall not be allowed to run at large for the present year. And be it further enacted, that if any of the above mentioned animals are found running the owner shall pay a fine of Five Shillings for each Horse, Bull, Boar, Ram, or Stag and for each Hog, or Pig a fine of One Shilling, Provided always that no such fine shall be inflicted unless it can be proved that the above mentioned animals were found running through the neglect of the owner.

By Law No. 9

A By Law to regulate the duties and liabilities of Bathmasters and other persons performing Statute Labour or liable to perform Statute Labour in the several Wards or Divisions in this Township.

Be it enacted by the Municipality of this Township and it is hereby enacted that all persons appointed or confirmed by the Council as Bathmaster or overseer of each Division shall after receiving notice of his appointment take

take the oath of office before the Township Clerk as required of all other Township officers and on receiving his instructions from the Clerk to proceed and lay out the Statute Labour in his Division in such place or places as he thinks may be the most servisable to the Division over which he is master, or in such places as the Council may by By Laws Direct and his duty shall be to notify or cause to be notified either in writing or verbally every such person liable to perform Statute Labour in his Division, by giving not less than Three days notice of the day hour and place where such labour is to be performed, to direct every person to bring with him such tools and implements useful for the purpose as he may be the owner of and to require that he do either in person or by an able bodied man work and perform such Labour and in such way as he shall direct, and when and where a team waggon or plough is required he shall in his Notice State to such owner what team waggon or plough he shall bring or send to perform such labour as may be required and if any person refuse or neglect to send such team waggon or plough as herein required such owner shall be fined in the sum of five shillings for each and every day of such refusal or neglect the same to be recovered as all other fines, Provided always that no such fine shall be imposed unless it is on the Complaint of such pathmaster or overseer of such division and such complaint must be made to the Township Reeve and in his absence then before any justice of the Peace and the Township

or any justice of the Peace may remit the fines hereby imposed, or any part of such fines on hearing such complaints; Provided always that nothing herein contained shall be construed to exempt any such person from performing his portion of Statute Labour.

And be it further enacted that any Pathmaster or overseer of such Division neglecting or refusing to take the oath as herein required or refusing or neglecting to call out the Statute Labour in his Division, or neglecting to notify such person so liable to Statute Labour shall forfeit and pay the sum of Five Pounds.

And be it enacted, That one days work, with Team waggon or plough shall be held an allowed as an equivalent to two days personal Labour of one man, that eight hours work exclusive of the time of coming and returning shall be considered and allowed as a days work, and that no such Pathmaster shall insert in the Third Column of his returns unless he has faithfully complied with all the requirements of this By Law and duly performed the same.

And be it further enacted That every Pathmaster or overseer whose duty shall require his attendance for the performance of such Statute Labour shall

shall exceed the number of days that he may be assessed for as on the assessment Roll, such Pathmaster or overseer shall be allowed on his next years Statute Labour for each and every day so employed, Provided always that each and every such Pathmaster shall take an oath or affirmation before the Township Reeve or Township Clerk that he has duly performed the same over and above the portion he was assessed for,

By Law No. 10
