First Meeting

Monday January the 21st / 1856
The Council met at Hiram Moore's at 11 o'clock A.M.
when the different Councillors was called and
answered to their names as follows viz - From Ward

Moved by Mr. Sheppard seconded by J. Morton that the Clerk be authorised to post up notices in three or four places concerning the roads about to be established in this Township - Carried No 4

Moved by Mr. Sheppard seconded by J. Morton that there be expended upon the public Roads in this Township the sum of thirty four pounds in the present year, and that it be distributed as follows viz, To David Sprague the sum of four pounds, To Mr. Martin four pounds to Friend Morton seven pounds, To John Morton seven pounds To Edward Sheppard Twelve pounds, and that they employ whatever pathmaster or pathmasters or commissioners they see fit to expend the same wherever they see proper and to make their several returns as the By-Law directs and also to make their returns on or before the first day of September next David Sprague & Co.
