Regular Meeting held at Belhaven on above date. members all present. minutes of previous meeting read and confirmed.

The trustees of school section No 1. applied to raise by debentures \$2500⁰⁰ Two thousand five hundred Dollars for payment of new school-house.

A petition of Isaac Marritt and one hundred and fifty-eight others was presented asking that a Bylaw in favor of local option be submitted to the Electors. also a Bylaw Petition asking to have all roads or streets not occupied by the corporation sold & leased.
