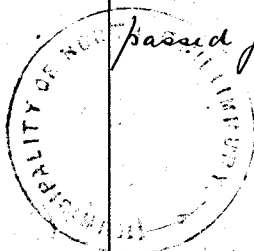


A Bylaw to appoint Auditors to audit the accounts of the Township of North Guillemburg for the Year 1886 also to appoint an assessor for 1887

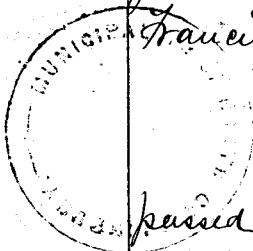

A Bylaw to amend Bylaw No 406, also to form a new Road Division, and make some provisions in regard to overseers of Highways duties

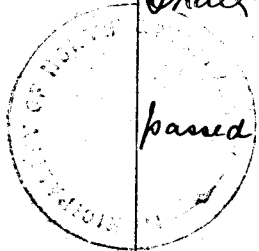
Be it enacted by the Council of the Corporation of the Township of North Wellfleet

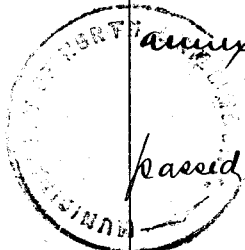

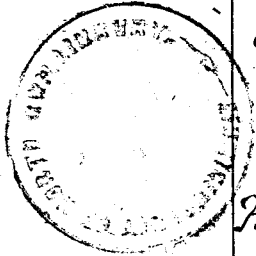

A Bylaw to assess for County purposes, for General Township purposes, On account of the Lake Simcoe Junction Railway (Co Bylaw) also Lake Simcoe Junction Railway (Tp Bylaw) and for the several school sections, as ordered by the Trustees of said sections.

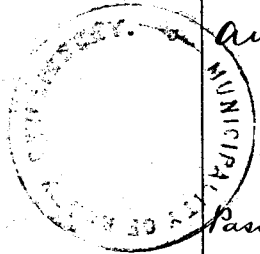
Whereas the Rev-Sta-Act gives power to Municipal Councils to levy and collect rates, for all purposes except school rates; and whereas the amended School Act makes it the duty of Township Councils to collect rates when application is made as aforesaid

Therefore be it enacted by the Council of the Corporation of the Township of North Simcoe, and it is hereby enacted by authority of the same; That there be levied, and collected from all the rateable property on the Assessment Roll for 1887, the sum of Five thousand nine hundred and thirty five Dollars and five and one quarter cents Being a rate of $6\frac{1}{2}$ mills on the \$, That is to say, For County purposes the sum of nine hundred and thirteen Dollars and eight and one-half cents Being a rate of 1 mill on the \$ For General Township purposes the sum of one thousand eight hundred and twenty six Dollars and seventeen cents, Being a rate of 2 mills on the \$, For payment of School Teachers the sum of two hundred and twenty eight Dollars, twenty seven and one eighth cents, Being a rate of $\frac{1}{4}$ mills on the \$, For Industrial Home, the sum of Two hundred and twenty eight Dollars, twenty seven and one eighth cents, Being a rate of $\frac{1}{4}$ mill on the \$, For Lake Simcoe Junction Railway (Co By-law) the sum of nine hundred and thirteen Dollars and eight and one-half cents Being a rate of 1 mill on the \$ For Lake Simcoe Junction Railway (Tp Bylaw) the sum of One thousand eight hundred and twenty six Dollars and seventeen cents, Being a rate of 2 mills on the \$

And for the several school sections, to be levied on the property in said sections, as near as may be the following amounts, viz

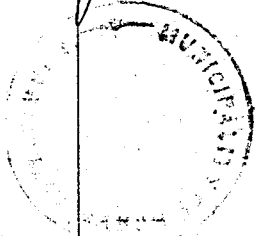
Bylaw No 413

A Bylaw to fix the place for holding the nomination of Candidates for the Offices of Reeve, Deputy-Reeve and Councillors for the Year 1888; also the place for holding the Election in the several polling-divisions, and appointing Deputy Returning Officers

Whereas in accordance with (42 Vic cap 18) it becomes the duty of Township Councils to pass Bylaws appointing the place of holding the Nominations and Elections, in the several Municipalities

Therefore the Council of the Corporation of the Township of North Gwillimbury enacts as follows

That the Election ^{Required} for the Year 1888 be held at the following places

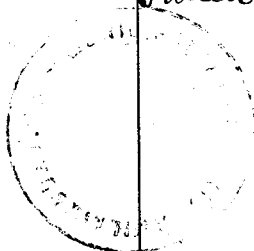

A Bylaw to close and sell a part of the Town-line between the Municipalities of the Townships of North Gwillimbury and Georgina.

Whereas the Act of the Legislature of Ontario 46 Victoria - Chap 18, Sec 566 Sub Sec 2 of the consolidated Municipal Act of 1883 empowers Municipal Corporations to sell and close an original Road Allowance and the Municipal Corporations of the Townships of Georgina and North Gwillimbury have mutually agreed to sell and close a part of the Town-line between the said Municipalities

And whereas the consolidated Municipal Act 46 Victoria - Cap 18 - Sec 546 - Sub Sec 1.2.3 & 4 having been complied with

Be it therefore enacted by the Council of the Corporation of North Gwillimbury

That a portion of the Town-line between the Municipalities of Georgina and North Gwillimbury be closed and sold in accordance with the Act - that is to say, that portion of the Town-line commencing where a cut stone monument has been planted at the South west angle of Lot one in the South Concession of Georgina thence North sixteen degrees west along the west limit of said Lot two chains and fifty-five links to high water mark on the mill pond - Then South Westly along the road one chain to the west limit of the said Original Allowance then South sixteen degrees East two chains more or less - then North Seventy-four degrees East one chain to the place of beginning.

Also all that part of the said Original
allowance lying and being between the mill-pond
and the south limit of the Newmarket road and
more particularly described as commencing on the East
limit of said Original allowance at the distance
of fifty-three chains and ninety links from the North
west angle of Lot number one in the seventh
Concession of Georgia, then in a South westerly
direction along the mill-pond at high water mark
one chain to the west limit of the Original allowance
Then north sixteen degrees west five chains thirty
four links to a cut stone monument on the
south limit of the Newmarket road - Then North Easterly
along the said road one chain more or less
then south sixteen degrees East five chains
thirty four links to the place of beginning -
Containing fifty-three hundredths of an acre.
