Bylaw No 441

A Bylaw to assess for County purposes, for General Township purposes for Lake Simcoe Junction Railway Bonus, and for the several school sections as required by the Trustees of said sections

Whereas the (Rev Sta Act) gives power to municipal Councils to levy and collect rates for all purposes above-mentioned.

Therefore the Council of the Corporation of the Township of North Willimbury enacts as follows

That there be levied and collected from all the rateable property on the assessment Roll for 1891, the sum of Five thousand, Eight hundred and sixty-seven dollars and twenty cents being a rate of $7\frac{1}{4}$ mills on the \$.

That is to say, for General Township purposes, the sum of Fifteen hundred and fourteen dollars and twenty-five cents, being a rate of 2 mills on the \$;

For Leo purposes, the sum of Eleven hundred and thirty-five dollars and sixty-eight cents, being a rate of $1\frac{1}{2}$ mills on the \$,


For payment of School Teachers, the sum of one hundred and eighty-nine dollars and twenty-eight cents, being a rate of $\frac{1}{4}$ mills on the \$,

For Industrial Home the sum of one hundred and eighty-nine dollars and twenty-eight cents, being a rate of $\frac{1}{4}$ mills on the \$.

For Lake Simcoe Junction Railway, the sum of Eleven hundred and thirty-five dollars and sixty cents, being a rate of $1\frac{1}{2}$ mills on the \$ for Leo Bonus, and Seventeen hundred and three dollars and fifty-three, being a rate of $2\frac{1}{4}$ mills on the \$ for Lp Bonus,

And for the several school sections to be levied on the property in said sections as near as may be the following


