



A Bylaw to open certain public Highway in the Township of North Gwillimbury.

Whereas it is ^{considered} desirable by the Council of the Corporation of the Township of North Gwillimbury to open certain public Highways in said Township.

And whereas the requisite notice of the intention to pass a Bylaw to open up said public Highways has been given as required by the Municipal Act;

Be it therefore enacted by the Municipal Council of the Said Township of North Gwillimbury, pursuant to the provisions of Municipal Act:

12¹ That the several Highways hereinafter mentioned shall be and are hereby declared to be opened up for public Travel and established as public Highways for the convenience of the public and subject to the general law respecting public Highways from and after the date of the passing of this Act namely:—

All that part of the Original Road allowance to the East of the Gun Swamp road to the Black River between Lots 15 and 16 in the 7th Concession of said Township, also all and singular that certain parcel or tract of land and premises situated, lying, and being in the Township of North Gwillimbury in the County of York in the Province or Ontario, being composed of a road one chain in width in lieu of the Original allowance for road in front of Lots 20-21-22-23 in Concession 7 of said Township, and which said parcel is more particularly described as follows:— Commencing at a post marking the Southwesterly angle of said Lot 20, thence northerly in a straight line to a point in the Northerly limit of said Lot 23, where the same is intersected by the centre of a rail fence fence forming the westerly limit of said Lot 23 as now occupied. Thence westerly along the southerly limit of the road allowance forming the northerly limit of said Lot 23, 1 chain, Thence southerly along the westerly limit of said road in lieu

of the original road-allowance to a point opposite said South Westly angle of said lot 20, thence Eastly, 1 chain to the place of beginning. The said road in lieu of original road allowance having been surveyed and defined by Provincial Land Surveyor J. B. Spright in accordance with an agreement made and signed by the several owners of the lands in concessions 6 and 7 immediately adjoining the aforesaid original allowance for road,

also all and singular that certain parcel or tract of land and premises situate lying and being in the Township of North Givlinbury in the County of York and Province of Ontario being composed of a portion of the original allowance for road between Lots numbers 20 and 21 in concession 7 of the said Township, being that part of said allowance for road lying to the west of the road crossing said lots and known as the "Newmarket Road", and of which said parcel may be more particularly described as follows --- Commencing at a point where stake has been planted to mark the South Westly angle of said Lot 21, thence Southly along the Westly limit of said Concession 7, 1 chain to a stake defining the North Westly angle of Lot 20. Thence Eastly along the Northly limit of said Lot 20, 41 chains and 93 links to an iron bar at the intersection of said Northly limit with the Westly limit of said "Newmarket Road". Thence Northly along the last mentioned limit to a stake marking the intersection of the ^{East} limit of "Newmarket Road", with the Southly limit of said Lot 21, thence Westly along said Southly limit 42 chains and 33 links more or less to the place of beginning. 566, sub-sec 2, gives Municipalities the power to open Public highways
