Bylaw No 491

A Bylaw to license regulate and govern transient Traders.

Whereas the Consolidated Municipal Act, empowers Municipal Councils to enact Bylaws for licensing regulating and Governing transient Traders.

1st

Be it therefore enacted by the Council of the Corporation of the Township of North Willimbury, and it is hereby enacted by Authority of the same: That transient traders and other persons, who occupy premises within the Township of North Willimbury for temporary periods, and whose names have not been duly entered on the Assessment Roll in respect of Real or personal property, for the three current year; shall before offering goods or merchandise of any description for sale by Auction or otherwise; take out a license therefor from the Treasurer of this Municipality, who is hereby authorized to issue the same

Be it therefore further enacted that each such transient trader or other person as aforesaid requiring a license under the provisions of this Bylaw shall pay therefor the sum of \$40⁰⁰ Forty dollars.

And be it further enacted that any person or persons contravening the provisions of this Bylaw shall upon conviction before a Justice of the Peace having jurisdiction in this Municipality, be liable to a fine of not less than five nor more than forty dollars and in default of payment, a distress warrant to issue against the goods and chattels of the offender, and in default of distress to be imprisoned in the common jail for a period of not less than ten days; this Bylaw to take effect from April 17th 1897

A Bylaw to assess for County purposes, for General Township purposes, and for the several school sections, as required by the trustees of said sections.

Whereas power is given Municipal Councils, to levy and collect rates for all purposes above-mentioned; therefore the council of the Corporation of the Township of North Gwillimbury, enacts as follows;

That there be levied and collected from all the rateable property, on the Assessment Roll for 1897, the sum of Three Thousand three hundred and thirty four Dollars and five cents, $3334^{\frac{05}{100}}$ being a rate of $4\frac{1}{2}$ mills on the \$.

That is to say, for General Township purposes the sum of, One thousand eight hundred and fifty two dollars and twenty-five cents $1852^{\frac{25}{100}}$, being a rate of $2\frac{1}{2}$ mills on the \$, for County purposes the sum of One thousand one hundred and eleven dollars and thirty-five cents $1111^{\frac{35}{100}}$, being a rate of $1\frac{1}{2}$ mills on the \$. For Industrial Home, the sum of Three hundred and seventy dollars and forty-five cents, $370^{\frac{45}{100}}$, being a rate of $\frac{1}{2}$ mills on the \$.

And for the several school sections to be levied on the property in said sections, as near as may be the following amounts, viz
