Bylaw No 503

a. Bylaw to assess for County purposes, for General Township purposes, and for the several school sections as required by the Trustees of said sections.

Whereas power is given Municipal Councils to levy and collect rates, for all purposes above mentioned
Therefore the Council of the Corporation of the Township of North Wellington makes as follows:

That there be levied and collected from all the rateable property on the Assessment Roll for 1899, the sum of \$3570⁵⁷ Three thousand five hundred and seventy dollars and fifty seven cents, being a rate of 4 $\frac{3}{4}$ mills on the \$.

That is to say. For General Township purposes the sum of \$751⁷⁰ seven hundred and fifty one dollars, and seventy cents. being a rate of 1 mill on the \$. For General School rate. the sum of \$1127⁵⁵ Eleven hundred and twenty seven dollars and fifty five cents. being a rate of 1 $\frac{1}{2}$ mills on the \$. For County purposes. the sum of \$1691³² sixteen hundred and ninety one dollars and thirty two cents being a rate of 2 $\frac{1}{4}$ mills on the \$.

And for the several school sections
to be levied on the property in said sections
as near as may be the following amounts:

Bylaw No 504

A Bylaw to make provisions for the preservation of Public morals within the Township of North Gwillimbury.

Whereas by the Revised Statutes of Ontario 1897, Chapter 223 section 549, Power is given to the Councils of Municipalities to pass Bylaws for the purposes therein named.

The Council of the Corporation of the Township of North Gwillimbury enact as follows

- 1st It shall not be lawful for any person to circulate any indecent placards, writings, or pictures, or the writing of indecent words or the making of indecent pictures or drawings on walls or fences in streets or public places.
- 2nd It shall not be lawful for any person to be drunk ^{guilty of any} or disorderly conduct in any streets or highways, or at any public meeting held for a lawful purpose.
- 3rd It shall not be lawful for any person to utter any profane oath or obscene, blasphemous or grossly insulting language or to commit any other immorality or indecency in the municipality.
- 4th It shall not be lawful for any person to keep any house of ill fame
- 5th It shall not be lawful for any person to open or keep any gambling house in which any Faro-Bank, Rouge et noir, Roulette table or other device for gambling is kept, and it shall be the duty of any peace officer, to seize and destroy any device used for the purpose of gambling when found therein.

- 6th It shall not be lawful for any person to Bathe, or indecently expose his or her person by washing in any water near any public highway between the hours of six o'clock in the morning and nine o'clock in the evening, unless provided and clothed in a proper bathing suit, sufficient to prevent any indecent exposing of the person.
- 7th It shall not be lawful for any person to be racing horses on any of the highways of this Municipality.
- 8th It shall not be lawful for any person to sell, or give any intoxicating drink to a child, apprentice, ^{master or legal protector} or servant without the consent of a parent or guardian.
- 9th Any person found guilty of any violation of any of the provisions of this Bylaw shall, upon conviction before any Justice of the Peace having jurisdiction in this County, be liable to a fine of not more than forty dollars, nor less than ~~five~~ one dollar, to be collected by distress and sale of the goods and chattels of the offender, if not paid within the time specified in the conviction; and in case no goods or chattels are found belonging to such offender it shall be lawful for any Justice to commit the offender to the common jail, used by the County, for a period not exceeding thirty days, with or without hard labor as the said Justice may direct.
- 10th One half of any fine imposed shall be paid to the informant and the other half to the Treasurer of the Municipality, for the use of the Township, unless the prosecution is brought in the name of the Corporation, in which case the whole of the pecuniary penalty shall be paid to the Corporation.
- 11th All information under this Bylaw shall be laid within three months from the date of commission of the offence.
