Be it enacted by the council of the Corporation of the Township of North Willimbury

H. J. C. 1st That John Hamilton p and John Marritt p be and are hereby appointed Auditors to audit the accounts of the Township of North Willimbury; and that they receive the sum of Three Dollars each for their services as such.

H. J. C. 2nd That Wayman Prosser, be and is hereby appointed Assessor for the Township of North Willimbury for 1908 at a salary of sixty-five dollars.

H. J. C. 3rd That David Sprague be and is hereby appointed collector for the Township of North Willimbury for 1908 at a salary of fifty dollars.

H. J. C. 4th And that Charles Stephens be and is hereby appointed a member of The Board of Health for a period of three years.

Bylaw no 558

To make provisions and regulations to secure a General Uniform Valuation of Sheep Killed or injured by dogs; and to appoint appraisers.

Whereas Chap 271 R. S. O. provides for remuneration by councils to owners of sheep killed or injured by dogs, and that the circumstances attending the said damages suffered as also the valuation of the loss incurred shall be thoroughly investigated,

Therefore be and it is hereby enacted by the Council of the Corporation of the Township of North Wellington; that the following named persons and their successors in office be and they are hereby appointed appraisers for the purpose of valuing all sheep killed or injured by dogs whose owners intend applying to the Council for compensation under the provisions of the aforesaid Act.

W. M. Viz. John B Sprague, George Meuro, Wm Morrison,
 W. M. David Wight, Wm Mahoney, Frank Terry, Jas Nelson.

It shall be the duty of the above-named appraisers upon being notified to proceed to the place where the sheep have been killed or injured and make and give to the owner of the sheep a valuation in writing and signed by him, which valuation shall be taken to the council and used as evidence as to the amount of injury done and loss sustained.

The appraisers shall receive as payment for their services the sum of one dollar for each occasion on which they are called to make a valuation. Said payment to be made by the Treasurer upon the order of the Reve.

W. M. The person suffering damage to his sheep by dog or dogs shall notify one of the appraisers within twenty-four hours of his knowledge of the event, and no person shall be a valuator of his own loss.

W.M. And it is further enacted that any claim made for damages suffered not complying with the above conditions, that the same may be refused consideration and remuneration by the Council for such noncompliance

Bylaw No 559

Whereas by Section 55 of clause 5 of Chap 19, 3 Edward VII, power is given to Township councils to pass Bylaws for regulating the construction and compelling the use of dry earth closets within limits to be defined by Bylaw of the Council.

And whereas it is deemed expedient by the Council of the Township of North Twillimburg, to compel the residents living along the borders of certain portions of Lake Simcoe to construct and use such closets,

Therefore be it enacted, by the Municipal Council of the Township of North Twillimburg; That it shall be the duty of every owner or occupier of every private house, hotel or boarding-house, situated on Lots 15. 16. 17. 18. 19. 20 21. 22. 23. 24. 25. 26. 27. 28 in the 2nd and Lake Concession and being within 300 feet from the Lakeshore Road to provide for the use of the occupants and guests of the same, a dry earth closet or closets of such dimensions and construction as shall be approved of by the Sanitary Inspector,

And it shall furthermore be the duty of such owners or occupants to provide sufficient dry earth, wood ashes, coal ashes, or other similar absorbent substance to absorb all the fluid parts of the deposit and such substance must be thrown upon the contents of such earth closets, daily; and the contents when removed when removed from the closets must be either buried or put in a shed or box with rain-proof cover and removed from the premises at least once a year,

all privy vaults and cess pools are hereby prohibited in the above-named district.

All such premises mentioned above shall be subject to inspection by the sanitary Inspector of the Township at all times and any person who violates or refuses to obey the conditions of this Bylaw shall be liable for every such offence to a penalty of not less than five Dollars; or more than fifty Dollars in the discretion of the convicting Justice or Magistrate besides legal costs which the Justice or Magistrate may see fit to allow

Whereas under the Public Health Act
R. S. O. Chap 248, Sec 31. Township Councils

as follows;

1st, That James Newbern be and is

Rat those not complying with the requirements
of the said Bylaw No 559, to the clerk of
the Township,

4th, That he shall be subject to the
Rat orders of the Board of Health when
required to carry out the requirements
of the Public Health Act

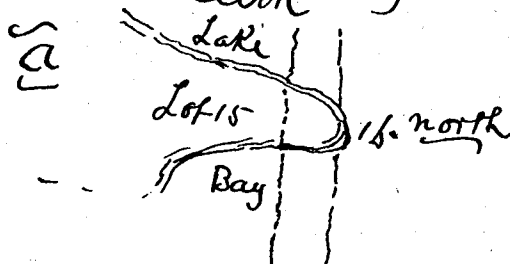
J. A. And whereas the owners of the land on each side of that part of the Road-allowance have offered (\$50⁰⁰) one hundred and fifty Dollars for the same,

A Bylaw to assess for County purposes, for General Township purposes, and for the several school sections as the law directs.

Whereas power is given municipal councils by the Consolidated Municipal Act, to levy and collect rates for all purposes above-mentioned

Therefore the Council of the Corporation of the Township of North Wellington enact as follows.

That there be levied and collected from all the rateable property on the Assessment Roll for 1908, the sum of \$6199³⁶ Six thousand one hundred and ninety-nine dollars and thirty six cents, being a rate of 6/4 mills on the \$, That is to say for General Township purposes, the sum of \$1733⁸² seventeen hundred and thirty-five dollars and eighty-two cents, being a rate of 1 3/4 mills on the \$, For General School purposes, the sum of \$2235⁷¹ Two thousand two hundred and thirty-five dollars and seventy-seven cents, being a rate of 2 1/4 mills on the \$, For County purposes, the sum of \$2235⁷¹ Two thousand two hundred and thirty-five dollars and seventy-seven cents being a rate of 2 1/4 mills on the \$.

And for the several school sections to be levied on the property in said sections as near as may be the following amounts
