A Bylaw to authorize the Head and Treasurer of the Corporation of the Township of North Gwillimbury to borrow certain sums to meet the now current expenditure.

Whereas the taxes levied for the current expenditure of the said Corporation for the Year have not yet been fully collected, there being uncollected of such taxes a sum not less than the sum hereby authorized to be borrowed.

And whereas the sum of Twelve hundred Dollars, will be required to meet the Current expenses of the said Corporation during the current year before the taxes levied therefor are collected, and it is expedient, subject to the conditions hereinafter contained, to authorize the Head and Treasurer to borrow the said sum.

Be it therefore enacted by the Municipal Council of the Corporation of the Township of North Gwillimbury as follows;

1st That the Head, with the Treasurer of the said Corporation, be, and they are hereby authorized, under the seal of the Corporation, but only in the manner and subject to the conditions below mentioned, to borrow from the Metropolitan Bank, the sum of Twelve Hundred Dollars required to meet the now current expenditure of said Corporation; provided always that the amount so borrowed and outstanding shall not at any time exceed the amount which may be legally borrowed, under the consolidated Municipal Act, to meet the now current expenditure of said Corporation.

Bylaw no 597

A Bylaw to assess for County purposes, for General Township Purposes; and for the several school sections as the Law directs.

Whereas power is given Municipal Councils by the Consolidated Municipal Act, to levy and collect Rates for all purposes above-mentioned.

Therefore the Council of the Corporation of the Township of North Gwillimbury enact as follows.

That there be levied and collected from all the Rateable property on the assessment Roll for 1912. The sum of \$7217⁵⁰/₁₀₀ Seven Thousand Two hundred and Seventeen dollars and fifty cents, being a Rate of 6 $\frac{1}{4}$ mills on the \$.

That is to say. For General Township purposes, the sum of \$2309⁶⁰/₁₀₀ Two Thousand Three hundred and nine dollars and sixty cents, being a rate of 2 mills on the \$.

For General School purposes, the sum of \$2309⁶⁰/₁₀₀ Two Thousand Three hundred and nine dollars and sixty cents, being a rate of 2 mills on the \$.

For County purposes, the sum of \$2598³⁰/₁₀₀ Two Thousand Five hundred and ninety-eight dollars and thirty cents, being a rate of 2 $\frac{1}{4}$ mills on the \$.

And for the several school sections to be levied on the property in said sections as near as may be the following amounts

A Bylaw for altering and diverting a Road at Roach's Point.

Whereas one Wilnot. D. Matthews, of the city of Toronto in the County of York Master, is the owner of all and singular that certain parcel or tract of land and premises (situate lying and being, part of Lot Twenty Three in the second concession of the Township of North Guillemburg in the County of York, containing an area of $\frac{63}{100}$ ths of an acre, be the same more or less, and which ^{said Parcel} may be better described as follows. That is to say; commencing from a point in the side-line between Lots Twenty Three and Twenty Four in the second concession of the Township of North Guillemburg where it is intersected by the easterly boundary of the Toronto and York Radial Railway where a mark has been affixed on a cedar fence post; thence south seventy four degrees west following the said line between said Lots Twenty Three and Twenty Four aforesaid; as it at present exists eight hundred and ninety-five feet six inches to a point where a post has been planted at the point of commencement; thence continuing south seventy four degrees west along the said line aforesaid, one hundred and eighty eight feet, to a point on the easterly limit of a road thirty three feet wide where a post has been planted; thence south seven degrees east following the easterly limit of said road one hundred and forty six feet to a point where a post has been planted; thence north easterly two hundred and sixty six feet six inches more or less to the point of commencement.

And whereas a public highway or road thirty three feet in width lies to the west-

and north of the above described parcel intervening between the said parcel and the property of the said Matthews to the north of the said Road.

And whereas the said Matthews has agreed to convey to the Corporation of the Township of North Guillemburg a strip of land forty feet in width along the south^{eastly} boundary of the said above-described parcel of lands and to construct thereon a road as good as the travelled road adjoining at his own expense, and has also agreed to convey to the said Corporation of the Township of North Guillemburg sufficient land at the south east corner of his property where the said road meets the railroad right of way and turns in a north easterly direction, to make the road at such turn the same width as the road to the east thereof by continuing the northerly limit of such road in a straight line to the northerly limit of the road running to the south of the property of the said Matthews in consideration for the conveyance by the Corporation of the Township of North Guillemburg to the said Matthews of the portions of Road lying to the north and west of the said above described parcel of land.

And whereas the said Matthews has so constructed a roadway as good as the travelled road adjoining and has agreed to execute a conveyance thereof to the Corporation of the Township of North Guillemburg; and to pay all expenses in connection with the exchange of property herein provided for,

Now therefore the Council of the Corporation of the Township of North Guilford enacts as follows;

1st, That the said road be altered widened and diverted in accordance with the said agreement, and that the said altered, widened and diverted road be, and the same is hereby established and opened as a public highway.

2nd, That those ~~portions~~ parts of the said road described as lying north and west of the said above described parcel of land be stopped up, sold and conveyed to the said Matthews.
