

## By-Law No 1034.

A By-Law to provide for the total 1942 Expenditure on roads in the Township of North Wellington in the County of York.

Whereas the Highway Improvement Act, Chapter R. 20. 1937 and amendments requires that the total expenditures on township roads and bridges be provided for annually by township by-law

Therefore the Council of the Corporation of the said township enacts as follows:

(1) The sum of \$15,000<sup>00</sup> is hereby appropriated from monies raised by levy, debentures and government subsidy for total expenditures upon construction and maintenance of the roads in in the said township during the year 1942 as follows:

Machinery	\$ 500
Superintending	\$ 1,000
Maintenance & Repair	\$ 13,500
Total Estimated Expenditure	15,000

(2) The said monies shall be expended under the direction of the duly appointed township road superintendent and in work performed in accordance with the latest regulations respecting township roads issued by the Department of Highways of Ontario.

(3) The clerk shall transmit a copy of this by-law to the Municipal Roads Branch, Department of Highways, for approval on or before February 28<sup>th</sup> of the present year.

A By Law to authorize the borrowing of \$30,000  
 Whereas the Council of the Corporation of the Township  
 of North Gwillimbury (hereinafter called the "Municipality") deems  
 it necessary to borrow the sum of \$30,000 to meet until taxes are  
 collected, the current expenditures of the Municipality for the year:

And whereas the total amount of the estimated revenues of  
 the Municipality as set forth in the estimates adopted for the  
 year 1942, not including revenues derivable or derived from arrears  
 of taxes, borrowings and issues of debentures, is \$63,000 <sup>00</sup> ~~00~~

Therefore the Council of the Township of North Gwillimbury  
 hereby enacts as follows:

(1) The Head and the Treasurer are hereby authorized on behalf of  
 the Municipality to borrow from time to time by way of promissory  
 note from The Canadian Bank of Commerce a sum or sums not  
 exceeding in the aggregate \$30,000 to meet until the taxes are collected  
 the current expenditures of the Municipality for the year, including the amounts  
 required for the purposes mentioned in subsection (1) of section 339 of the  
 Municipal Act, and to give on behalf of the Municipality to the  
 Bank a promissory note or notes sealed with the Corporate Seal and  
 signed by the Head and Treasurer for the money so borrowed, with  
 interest, which may be paid in advance or otherwise, at a rate not exceeding  
 five per centum per annum.

(2) All sums borrowed pursuant to the authority of this by-law, as  
 well as all other sums borrowed in this year and in previous years from  
 the said Bank for any or all of the purposes mentioned in the said section  
 339, shall, with interest thereon, be a charge upon the whole of the revenues  
 of the Municipality for the current year and for all preceding years as and  
 when such revenues are received.

(3) The Treasurer is hereby authorized and directed to apply in payment of  
 all sums borrowed as aforesaid, together with interest thereon, all of the  
 money hereafter collected or received either in account or realized in respect  
 of taxes levied for the current year and preceding years or from any other  
 source which may lawfully be applied for such purpose.

## By Law No 1035 A

A By Law to authorize the borrowing of \$10,000

Whereas the Council of the Corporation of the Township of North Guelphburg (hereinafter called the "Municipality") deems it necessary to borrow the sum of \$10,000 to meet until taxes are collected, the current expenditures of the Municipality for the year:

And Whereas the total amount of the estimated revenues of the Municipality as set forth in the estimates adopted for the year 1942, not including revenues derivable or derived from arrears of taxes, borrowing, and issues of debentures is \$63000<sup>00</sup>

Therefore the Council of the Township of North Guelphburg hereby enacts as follows:

- (1) The Head and the Treasurer are hereby authorized on behalf of the Municipality to borrow from time to time by way of promissory note from the Bank of Nova Scotia a sum or sums not exceeding in the aggregate \$10,000 to meet until the taxes are collected the current expenditures of the Municipality for the year, including the amounts required for the purposes mentioned in sub-section (1) of section 339 of the Municipal Act, and to give on behalf of the Municipality to the Bank a promissory note sealed with the Corporate Seal and signed by the Head and Treasurer for the money so borrowed, with interest, which may be paid in advance or otherwise, at a rate not exceeding five per centum per annum.
- (2) All sums borrowed pursuant to the authority of this by-law as well as all other sums borrowed in this year and in previous years from the said Bank for any or all of the purposes mentioned in the said section 339, shall, with interest thereon, be a charge upon the whole of the revenues of the Municipality for the current year and for all preceding years as and when such revenues are received.
- (3) The Treasurer is hereby authorized and directed to apply in payment of all sums borrowed as aforesaid, together with interest thereon, all of the moneys hereafter collected or received either on account or realized in respect of taxes levied for the current year and preceding years or from any other source which may lawfully be applied for such purpose.

## By Law No 1040

A By-Law to appoint an officer to issue Dog Licenses and Dog Tags and collect the fees for same in the Township of North Gwillimbury

Be it therefore enacted by the Municipal Council of the Corporation of the Township of North Gwillimbury

That Carl Morton be appointed to issue dog licenses and dog tags and collect the fees for same in the Township of North Gwillimbury for the year 1942 and during the pleasure of the Council. That for his services as such collector he be paid the sum of 15 cents per Dog License issued

That all monies collected under the provisions of this By Law shall be paid over to the Treasurer of the Municipality together with a record of the number of all dog tags and duplicate copies of all licenses issued. By Law No 1040 A

A By Law to provide for the licensing of dogs in the Townships of North Swillimery and to provide for enforcement of the Dog Tax and Livestock Protection Act.

Be it therefore enacted by the Municipal Council of the Corporation of the Township of North Swillimery.

That a license fee be imposed on the owners of all dogs in the Township of North Swillimery and a license shall be required for every year in respect of each dog owned or habitually kept on the premises:

That the fees payable for such licenses shall be

For a male dog	\$ 2 00
For a fer ret dog	\$ 4 00
For a spayed female dog	\$ 2 00
For a kennel comprising up to 10 dogs	\$ 10 00

That on payment of the license fees the owner shall be furnished with a numbered dog tag and the provisions of the Dog Tax and Livestock Protection Act in respect of keeping the tag securely fixed on the dog shall apply.

That an officer duly appointed by the Council shall issue dog licenses and dog tags and collect the specified fees but the responsibility for securing licenses and tags shall rest with the owner of the dog. If for any reason the duly appointed officer fails to supply the license and collect the fee the owner may secure the same by applying to the said officer or to the township clerk.

That all owners of dogs shall be required to have the said licenses and tags in their possession by not later than the first day of June in each year. Where an owner acquires ownership of an unlicensed dog after the date specified he shall at once obtain a license and tag. If more than six months of the current year have elapsed before possession of the dog is acquired the owner shall be charged with one half the regular license fee.

That in respect of cases where the fee is demanded and not paid or in the case of dogs found running at large the provisions and penalties of the Dog Tax and Livestock Protection Act may be applied and enforced.

And all By-Laws or parts of By-Laws concerning taxes on dogs which are inconsistent with the terms of this By-Law shall be and are hereby repealed.

## By Law No 1041

By Law to provide for the payment of Taxes in advance and for discounts thereon.

Whereas by Section 113, of the Assessment Act, R. S. O. 1937, and sub-sections thereto, authorizing the mode of payment of taxes in advance for discounts thereon

And whereas in view of the large number of non-resident tax payers in the said Township, it is deemed advisable to have bills rendered and arrangements as to the payment during the summer season.

Be it therefore enacted by the Municipal Council of the Corporation of the Township of North Gwillimbury as follows:

1. Taxes for each year may be paid on the 30<sup>th</sup> day of August and the 15<sup>th</sup> day of October:
2. A discount of 2% shall be allowed on the amount of taxes paid on or before the 30<sup>th</sup> day August in the year in which they are due, and a discount of 1% shall be allowed on the amount of taxes if paid on or before the 15<sup>th</sup> day of October.
3. Any By Law now in force, and the provisions of which conflict with the provisions of this By Law is hereby repealed in so far only as it conflicts with the provisions of this By Law.

## By Law No 1043.

To By Law to provide for the mailing of Tax Notices

Whereas by the provisions of Section 109 of The Assessment Act R. S. O. 1937, Chapter 272 a Municipal Council is authorized to pass a By-law authorizing the Collector to mail the written or printed notice specifying the amount of taxes payable by the person taxed to the address of the residence or place of business of such person instead of personally delivering such notice to such person.

And whereas it is deemed expedient to pass such a By-law in the Township of North Wellington

Be it therefore enacted by the Municipal Council of the Corporation of the Township of North Wellington as follows:

1. Instead of calling at the residence or place of business of the person taxed as provided by Section 109(1) of The Assessment Act R. S. O. 1937, Chapter 272, the Collector may hereafter mail the notice specifying the amount of taxes payable by a tax payer or cause same to be mailed to the address of the residence or place of business of such person and the mailing of such notice as aforesaid shall be good and sufficient delivery of the said notice to such person and shall constitute a good and sufficient demand for payment of the taxes.

2. This By Law shall take effect on the date of the final passing thereof and shall apply to the delivery of tax bills for the year 1942.

## By Law No 1044

A By Law to assess for County purposes, Township purposes, school purposes, and the special taxes as directed by the Statutes.

Whereas the Municipal Act requires Municipal Councils to assess and collect for all taxes above mentioned during the current year.

Therefore the Municipal Council of the Corporation of the Township of North Simcoe hereby enacts as follows:

That there be levied and collected from all the rateable property in the Township of North Simcoe for the year 1942 as follows:

That in to say for County purposes the sum \$15,921.04, being at the rate of 7 $\frac{1}{10}$  mills on the dollar.

For Township purposes the sum of \$3,587.84, being the rate of 1 $\frac{4}{10}$  mills on the dollar.

For Roads and Bridges the sum of \$1,090.80, being at the rate of 4 $\frac{7}{10}$  mills on the dollar.

Special Levy for direct relief, charity and hospitalization for the sum of \$2,915.12 being at the rate of 1 $\frac{3}{10}$  mills on the dollar.

For the General School Rate the sum of \$4,933.28, being at the rate of 2 $\frac{7}{10}$  mills on the dollar.

For the Trustee Levy in the different school sections as near as may be to the following amounts:

D.S. No 1. \$920<sup>14</sup> being at the rate of 2 $\frac{9}{10}$  mills on the dollar.

D.S. No 2. \$1,929<sup>42</sup> being at the rate of 4 $\frac{9}{10}$  mills on the dollar and for debentures the sum of \$1,299<sup>24</sup>, being at the rate of 3 $\frac{3}{10}$  mills on the dollar.

D.S. No 3. \$383.36, being at the rate of 8 $\frac{1}{10}$  mills on the dollar.

D.S. No 4. \$566.22, being at the rate of 3 $\frac{7}{10}$  mills on the dollar.

D.S. No 5. \$602<sup>80</sup>, being at the rate of 4 $\frac{4}{10}$  mills on the dollar.

D.S. No 6. \$1,129.84, being at the rate of 1 $\frac{9}{10}$  mills on the dollar.

D.S. No 7. 437.05, being at the rate of 4 $\frac{9}{10}$  mills on the dollar.

D.S. Union Brownhill 49.20, being at the rate of 6 mills on the dollar.

Special Levy for Oil on roads for the sum of \$450<sup>00</sup>, being at the rate of 4 $\frac{9}{10}$  mills on the dollar on assessment of the properties concerned.

Special Levy for the collection and disposal of garbage for the sum of \$1,852.58, being at the rate of 1 $\frac{7}{10}$  mills on the dollar.

Special Levy for street lights in the Village of Heswick and Plan 130 Cor 2 for the sum of \$381<sup>29</sup>, being at the rate of 4 $\frac{7}{10}$  mills in Heswick village and 1 mill in Plan 130.

A Tax for such sums as may be necessary to meet arrears due to the Hydro Electric Power Commission to be levied against such properties as may be concerned.

The General Tax Rate has been reduced one mill by reason of the Provincial subsidy to Municipalities.
